The Melukavu HBC Co-operative Society Ltd. K916 has been registered as per the provisions of the Kerala Co-operative Societies Act, 1969 on 24-05-1995 and the society commenced its business on 29-05-1995. There are 62 A Class members, and 2,791 B Class members. The members of the society are the students and staff of HBC. The authorized share capital of the society is Rs. 1,00,000/- and issued, subscribed, called up & paid up capital is Rs. 66,820/-. The society keeps all the relevant books of accounts, documents and registers prescribed in the Rules, Act and Byelaw.

The society runs its operation in a separate building on the campus and does its operation every working day since the academic year 1995. The society caters the basic needs of the student community such as stationery, textbooks, notebooks, sweets, consumables, etc. at an affordable price.

The meeting held on 10-06-2019 at 3.30 pm in the office of the principal in the presence of the Principal Dr. Gireesh Kumar G S who is also the president of the society, ex officio along with Jenipher Carlos Hosanna, Dr. Santo Jose, Ms. Ashly Mereena Mathew, Mr. Justin Jose, Mr. Isson George, Mr. Jomon K Joseph Mr. Shinu Thomas P and Mr. Justin J Paul reelected Mr. Jenipher Carlos Hosanna, Assistant Professor, Department of Commerce as the secretary of the college cooperative society for the financial year 2019-2020. The meeting also elected Ms. Ansa Andrews and Mr. Paul Mathews as new members.

The meeting authorized Mr. Jenipher Carlos Hosanna, the secretary of the society to maintain the college cooperative society according to the interest of the students by providing them all the essential stationery, eatables, sweets, etc. The meeting also authorized the secretary for the safe custody of books of accounts, registers, documents, etc.

The society met the needs of the HBC student community by providing them the requisite items/ stationery/sweets/eatables, etc.

The audit of books of accounts from the DCA was done on 18-12-2020 and an Audit Certificate cum Report is yet to be issued.
